



ORDER ACCEPTANCE FORM FOR MULTILAYER PE FILM(ULTIMATEPOLY™)

This is a contract for the supply of multilayer Poly ethylene films(PE films). These supplies are subject to following terms & conditions -

- 1) This contract shall be between Ultimate Flexipack Ltd. (the seller) and the buyer as principal dealing with principal and shall be deemed to be conclusive on placing the order by the buyer.
- 2) No allowance for short weight or measure shall be acceptable, unless notice of the same is given within 3 days after the receipt of goods by the buyer. Any complaint regarding any previous invoice of ours will not invalidate or detain the payment of the invoice.
- 3) Sales tax, excise duty, octroi and other applicable Government levies will be borne by the purchaser irrespective of they are included in Challan or Invoice.
- 4) Part quantity must be accepted by the customer, in case the full ordered quantity is not dispatched due to any reason. Quantity supplied may be $\pm 15\%$ of the ordered quantity.
- 5) Buyer must submit required sales tax form (for 'C' etc) within stipulated period of 60 days from the end of quarter, failing which the buyer shall be responsible for differential tax, interest, penalty and other incidental costs.
- 6) The buyer must make his own arrangement to test the goods supplied to him and must satisfy himself about the suitability of PE films for the specific purpose before putting them to use and the seller shall, under no circumstances, be responsible for any consequential loss to the buyer for using the PE films delivered. Any claim relating to the quality/ performance of the product shall not be entertained after any operation is conducted on Polyethylene films. Seller may consider replacing of only unused PE films, in case of any deviation from standard specifications is proven.
- 7) The buyer shall not be entitled to vary, amend, add or alter any of these conditions, in any manner whatsoever.
- 8) Interest @ 18% p.a. will be charged on bills not paid within due date. Delivery date is payment due date (unless otherwise specifically contracted).
- 9) Any dispute is subject to Jammu / Haridwar jurisdiction only.
- 10) Thickness of the film may vary upto $\pm 7\%$ and approximately 15% points may fall outside this limit.
- 11) Width of the film may vary upto ± 5 mm depending on the thickness.

By placing the order on us, it is assumed that you agree to the terms & conditions of this **order acceptance letter** and these terms and conditions are valid for current as well as all future orders to be placed by you.
